# W2W Progress Report

- ▣ UNIV 1000/INTL 1000
  - Initiating Experience Change (UNIV 100)
  - Six W2W Events this Fall (INTL 1000)
  - Over 700 participants in these events

- ▣ INTL 3900 W2W Capstone
  - 23 students registered in INTL 3900 Fall 2016
  - 18 of the 23 completed the requirement
  - None of the 23 was a graduating senior

  - What will the initiating experience be?
  - Participation in Baseline Assessments
  - Completion of post seminar surveys
- ▣ Requirement Completion
