 - **Spring 2024**

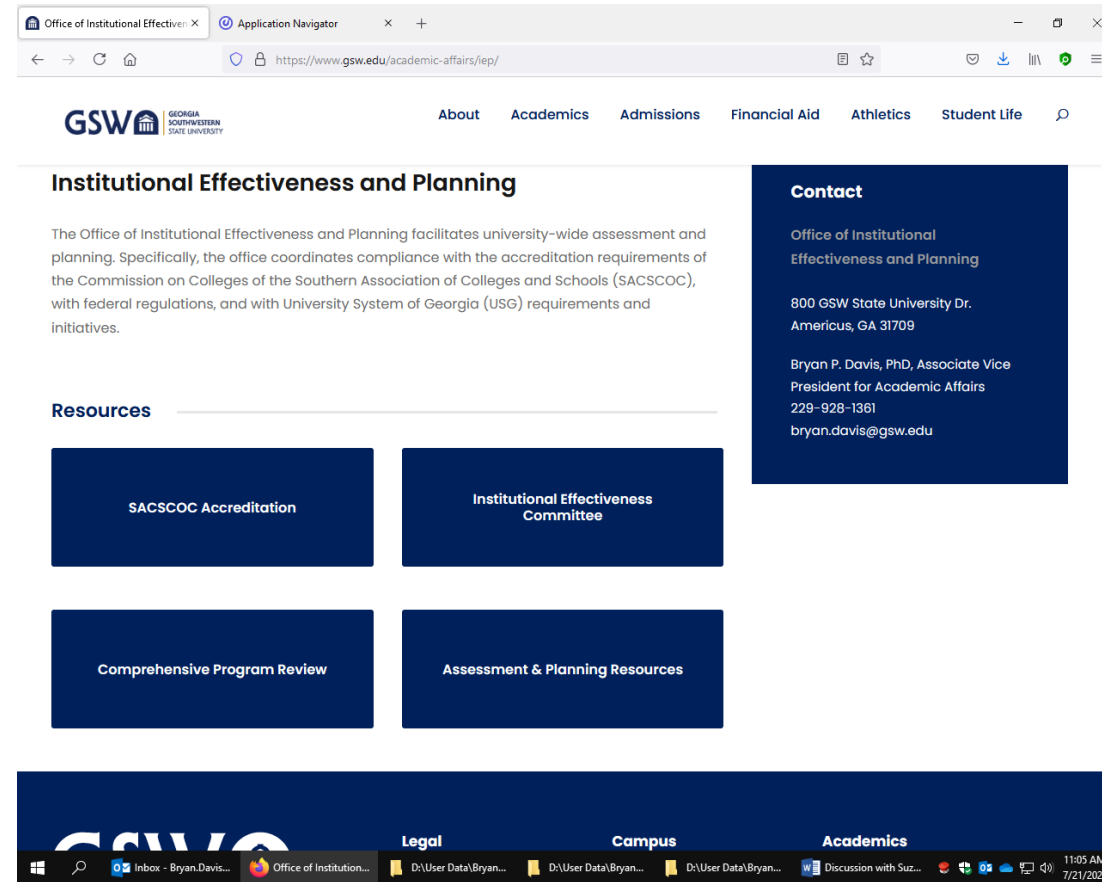
What do we need to be in compliance?

- Administrative Units Standard 7.3:
 - The institution identifies expected outcomes of its administrative support services and demonstrates the extent to which the outcomes are achieved.
 - We need a record showing that all Administrative Units have met this standard annually.
- All Administrative Units need a plan and evidence for
 - **2020-21**
 - **2021-22**
 - **2022-23 (submitted early in Summer 2023)**

What do we need to be in compliance?

- Academic and Student Support Units Standard 8.2c:
 - The institution identifies expected outcomes, demonstrates the extent to which it achieves the outcomes, and provides evidence of seeking improvement based on analysis of results in academic and student services that support students.
 - We need three-year trend reports from all units in fall 2022 that include all three elements.
- Three-Year Assessment Cycle
 - 2019-20—Assessment plans and review of plans by IEC; collect data
 - 2020-21—Assessment Revisions, if any; collect data
 - 2021-22—Three-Year Trend Report (will be due in October 2022)
