Final Report on W2W as QEP

- 54 Events hosted between Fall 2014 and Spring 2019
- UNIV 1000 Essay Assessment 467 Essays Assessed
- INTL 3900 Essay Assessment 401 Essays Assessed
- Global Perspectives Inventory (GPI) showed improvement from UNIV 1000 to INTL 3900
- Event Surveys
