• **Strategic Plan Assessment Task Force**

David Jenkins reported that all Qualitative assessments were completed.

- Assessment rated by Closely Aligned, Aligned, Slightly Aligned, or Not Aligned
- Compiled data broken down to percentages of Closely Align/Aligned and Slightly Aligned/Not Aligned
- Both Objective 1.3 and Objective 3.1 = 71% Closely Align/Aligned
- Objective 2.3 (57%) and Objective 3.3 (50%) had high percentages of Slightly Aligned/Not Aligned, as well as low numbers quantitatively.
